**Entries will only be considered valid upon payment of 50% of the total cost of participation.** The remaining amount shall be settled no later than **02 of October, 2026**.

- **STANDS DECORATION**

The decoration of the Stand will be the sole responsibility of the Exhibitor, except for the name of the Stand previously filled in on the Registration Form. Materials placed on the stand structure by the exhibitor, including vinyl advertising images and tarpaulins, among others, must be removed immediately after the Fair in order to leave the structure clean. Otherwise, FIC will hire a company to remove/clean the materials, charging the costs to the exhibitor.

## « ADDENDUM TO THE GENERAL REGULATIONS »

### • **article 1 - ADMISSION OF REGISTRATIONS AND ALLOCATION**

- The **acceptance of participation** is also the responsibility of FIC, which may refuse any registration that does not align with the objectives of the fair, or that, for any reason, is deemed inconvenient or detrimental.
- The **allocation of spaces** is the exclusive responsibility of FIC, which will decide the location of participants considering factors such as: sector classification, requested area, order of registration receipt, exhibitor seniority, economic or technical criteria, and the overall harmony of the Fair.

### • **article 2 - ASSEMBLY AND DISMANTLING**

#### - **Assembly period:**

The period and schedule for assembly will be defined by the organization and communicated in advance, being published in the General Regulations delivered to exhibitors.

#### - **Additional time:**

For **Modular Stands**, assembly **begins 2 days** before the inauguration, from **09:00 to 20:00**, and **ends at 12:00** on the inauguration day.

For **Customized Stands**, assembly **begins 10 days** before the inauguration, from **09:00 to 20:00**, and **ends at 12:00** on the inauguration day.

If the exhibitor requires **additional time or days**, a **SUPPLEMENTARY ASSEMBLY FEE** will be applied.

**Waste management:** Each exhibitor is responsible for collecting and removing the waste produced during the assembly and dismantling of their stand.

### • **article 3 - EXHIBITED PRODUCTS**

- During the FIC, it will not be permitted to **present or distribute products** that may cause harm to other exhibitors or visitors, or that may damage the flooring or existing structures of the venue. Exhibited products must remain in the stands throughout the fair, and removal will only be allowed in exceptional cases, with express authorization from the organization.

- The **presentation of products/loads** exceeding 1,000 kg/m<sup>2</sup> requires special authorization for vehicle/crane maneuvers, etc.

### • **article 4 - RULES OF CONDUCT**

- **Live music prohibition:** Live musical performances in the stands **will not be permitted**.

- **Disturbing sounds prohibition:** Any type of sound, recording, or noise that disrupts the proper functioning of the fair or disturbs neighboring stands will be prohibited.

### • **article 5 - ACCESS OF PERSONS**

- **Age restriction:** Entry of children and adolescents up to 16 years of age will not be permitted in the fairgrounds and stands during the fair, assembly, and dismantling periods.

### • **article 6 - PENALTIES**

- **Non-compliance with the established rules** will result in penalties
